Mr. Paul E. Brown is the founder and principal owner of CyberEvidence, Inc, an internationally recognized leader in computer forensic investigation and computer forensics training. Mr. Brown is listed in the national registrar of Who's Who for Executives and Professionals, and retains numerous certifications, including:

- the NW3C's Data Recovery and Analysis (ADRA) series of courses.

In recognition of his knowledge and expertise, the National Institute of Standards and Technology (NIST) asked Mr. Brown to contribute to the *Forensic Guide to Recovery of Electronic Evidence*. Mr. Brown was also asked to contribute material to John Vacca's latest book *Computer Crime Scene Investigation*.

Mr. Brown has served his country through four years in the United States Air Force, and has over 28 years in law enforcement. Currently, retired from the Houston Police Department, Mr. Brown continues his tenure as a Texas Peace Officer with a local department. Paul Brown has dedicated his professional career to the prosecution of criminals, the pursuit of knowledge, and the raising of awareness in computer technologies.
